# Bielefeld-based restructuring expert Dr Wehner from PLUTA finds investor for furniture component supplier LignoSmart

Dr André Wehner from PLUTA Rechtsanwalts GmbH has welcome news in the insolvency proceedings for LignoSmart Holztechnik GmbH based in Lübbecke: the creditors' assembly unanimously agreed the transfer of business operations to GELA-FORM Möbel GmbH & Co. KG from Herford during last week's report meeting at the Local Court of Bielefeld. The economic transfer took effect on 1 November 2024. The purchase agreement had already been signed in late October.

The acquisition means that all jobs have been saved and the site in Lübbecke has been preserved. It also ensures that customers in the furniture industry will continue to receive components of very high quality going forward. LignoSmart Holztechnik GmbH based in Lübbecke filed for insolvency due to liquidity problems. Following this, on 21 June 2024, the Local Court of Bielefeld ordered provisional insolvency proceedings and appointed Dr Wehner from PLUTA Rechtsanwalts GmbH as provisional administrator. In early September 2024, the proceedings were opened and the attorney was appointed administrator.
