# **PALUX AG and other companies involved in debtor-in-possession proceedings – PLUTA attorney Ilkin Bananyarli appointed provisional insolvency monitor**

After private investors (AURONA Capital GmbH and PENTAPART Beteiligungskapital GmbH) acquired a majority stake in GUSTATUS Holding GmbH in late October 2024, parts of the group had to file an application for debtor-in-possession insolvency proceedings, which was then approved by order of the Local Court of Crailsheim.
