# PLUTA attorney Florian Zistler appointed provisional administrator for MAXX Hotel in Aalen

On 27 January 2025, the Local Court of Aalen appointed attorney Mr Florian Zistler from PLUTA Rechtsanwalts GmbH as provisional insolvency administrator for Scoop Aalen Hotelbetriebs GmbH. The business operates the 4-star MAXX Hotel in Aalen.

Restructuring expert Mr Zistler is working with great urgency to obtain a comprehensive overview of the hotel's financial situation. "The hotel remains open, and staff are ensuring that guests continue to receive the usual high level of service," said Mr Zistler. He is being supported in the proceedings by Mr Dennis Stroh, Master of Laws (LL.M.).

In the next stage of the proceedings, the provisional administrator will initiate the process of securing pre-financing of the insolvency substitute benefits provided under German insolvency law. The wages and salaries of the more than 30 staff members will therefore be guaranteed for a period of three months. Employees were already informed about the current situation during a staff meeting.

The business has filed for insolvency due to financial constraints, which it attributes to a cyberattack. This fraud
