Solution found for Bavarian location of education provider erlebnistage

The PLUTA team has found a follow-up solution for the third location (Bavarian Forest) in the debtor-in-possession proceedings for erlebnistage gGmbH. This means that all three locations will be maintained. Solutions had already been found for the Harz Mountains and Lake Schwerin sites.

The newly established Erlebnistage Bayerischer Wald e.V. association has taken over the business in the Bavarian Forest and retained all 20 or so employees, with retroactive effect from 1 October 2025. The parties signed the related purchase agreement in late October 2025. The Wolfsteiner Hütte lodge was included in the transaction and has also been acquired. Constructive discussions concerning the company's Haus Wiesengrund and Haus Forellenhof properties are currently underway.

Ms Katharina Heimrath and Mr Tony Jäger, who had already been managing the Bavarian Forest site, will remain at the helm of the outdoor education expert's business there. Both managers are working alongside board members Mr Alex Ferstl and Professor Dr. Werner Michl in the newly established association. The provider specialises in outdoor education experiences offered through class and group excursions that foster sustainable education and personal development.
